# Africa LEDS Modelling and Planning – supporting transitions to inclusive low-carbon development

The recent publication of the Africa Progress Panel's 2015 Report has again highlighted that Africa has a huge development deficit. As the region attempts to reduce this deficit, undergoing a huge transformation in its socio-economic makeup, infrastructure, and more, various options arise as to how to transition to low carbon development pathways. Policy choices around energy provision, urbanization, water management, food security and others will have fundamental impacts not just on the emissions profile of Africa, but also on the development deficit, and the pathways through which it is narrowed.



In order for governments and civil society to be able to accurately assess the ramifications of such choices, and direct limited resources towards inclusive low carbon development, they must have access to the latest cutting-edge economy-wide models and knowledge, which must themselves be rooted in national and regional policy processes, and owned by governments.

The Africa LEDS Partnership (AfLP), as a key convener of low carbon stakeholders from civil society and beyond, is involved in a number of initiatives aiming to provide governments with the tools and information they need to be able to make these decisions, and is pleased to bring together a number of these for a topical and interesting discussion at COP-21. This event will focus on two particular modelling projects; a collaboration between the Africa LEDS Partnership, the United Nations Environment Programme, the European Commission and the Mitigation Action Plans and Scenarios (MAPS) program, with expert speakers and extensive audience participation expected to lead to a stimulating discussion around the future of Africa's development.

# Mapping the Future: Data Enables Smart Renewable Energy Growth

As part of the Enhancing Capacity for Low Emission Development Strategies program, the U.S. Agency for International Development, U.S. Department of State, and U.S. Department of Energy's NREL are partnering with developing countries to map renewable energy resource potential and use those maps to attract clean energy investment. Detailed renewable resource data, high-resolution maps, and analytical tools are foundational building blocks for scaling up renewable energy. This panel will outline the challenges, needs, and importance of comprehensive resource data in financing renewable energy projects and informing renewable energy policy. Speakers will share national experiences with mapping and deployment from both a government and industry perspective. Lastly, speakers will discuss how robust renewable energy data helps efficiently and resiliently integrate increasing levels of variable renewable energy into power systems.

# How countries can advance their transition to prosperous low carbon societies

Research programmes MAPS (Mitigation Action Plans & Scenarios) and the DDPP (Deep Decarbonization Pathways Project) are teaming up to host this discussion, featuring senior representatives from national governments, businesses, the donor community and non-profit organizations.
